How can I find information about a posted vacant position?

Contact the MAL Division Human Resources office at 936-437-6531 or visit the TDCJ website at www.tdcj.texas.gov, click on “Career Opportunities,” and “TDCJ Job Search” to search the current listing of job postings with the job title “EQUIPMENT OPERATOR I - Truck Driver.”

Is it required that I take a road test?

Yes. All applicants must successfully complete the *TDCJ Freight Transportation Road Test* to be qualified for an interview. Road tests will be retained in the active file for one year. To schedule a road test contact the appropriate freight terminal.

What qualifications must I have for a truck driver position?

- A valid Class A Texas Commercial Driver License (CDL).
- A valid CDL Medical Examiner’s certification statement issued within the last two years.
- Successful completion of the current TDCJ freight transportation road test within the past twelve months.
- Graduation from an accredited senior high school or equivalent or GED.

To obtain a complete job description and qualifications, contact the MAL Division Human Resources office or visit the TDCJ website.

To obtain the required application forms, please visit the TDCJ website, www.tdcj.texas.gov, click on “Career Opportunities,” and “Download a state job application.” Follow the download instructions for all required application forms.

What paperwork am I required to submit when applying for a truck driver position?

The following applications and documents must be submitted:

- State of Texas Application for Employment.
- The applicable application supplement:
Outside applicants - TDCJ Employment Application Supplement, PERS 282.
Current TDCJ employee applicants - TDCJ Employment Application Supplement for Agency Employees, PERS 598.
- Additional Offender Information, PERS 282A, if applicable.

A legible copy of the following documents must be attached to the State of Texas Application for Employment:

- Valid Class A CDL.
- Valid CDL Medical Examiner’s certification statement issued within the last two years.
- High school transcripts/diploma, college transcript/diploma or GED.
- Signed Social Security card.

Refer to the TDCJ Employment Application Supplement for minimum standards for all applicants, additional required documents and conditions of employment.
