

AUTHORITY

The Director of Health Services Division, Vice-President of Correctional Managed Care, TTUHSC Associate Vice President & Managed Care Medical Officer. Director of Support Services CMC, and the Chief Dietitian shall ensure that patients (offenders) are provided with appropriate therapeutic diets prescribed by the physicians and clinicians within the parameters of Policy 1-1.1 on Therapeutic Diets. The Unit Food Service Departments shall be held responsible for preparing and serving the Therapeutic Diets according to the guidelines provided in the Correctional Managed Health Care Therapeutic Diet Policy and Procedure Manual.


The Chief Dietitian shall be responsible for the development of the Correctional Managed Health Care Therapeutic Diet Polices and Procedure Manual and Therapeutic Diet menus incorporating the current Dietary Guidelines for Americans, 2020-2025, Ninth Edition, developed by the U.S. Department of Agriculture, the U.S. Department of Human and Health Services, and the Dietary Reference Intakes (DRI) (Food and Nutrition Board).
