**a. Identify the community-based organization(s) or victim advocates with whom you communicated:**

The facility in the past has had a Memorandum of Understanding (MOU) with InterAct to provide emotional support services to residents of the South Raleigh Residential Reentry Center. On that same date, the Senior Director, PREA Programs and Compliance contacted CoreCivic's Legal Department to request a new MOU be written. The new executed MOU was signed on by the President and CEO of the Purple Door on 1/21/25 and by the Vice President, Core Services on 1/25/25 and forwarded to me for my review on 1/27/25. The Director of Sexual Assault Services of InterAct was contacted on 1/30/25 to confirm and review the terms of the MOU. InterAct provides residents of the South Raleigh Residential Reentry Center with a 24-hour crisis hotline answered by volunteer and paid advocates during business hours and by a confidential answering service after hours and weekends. Calls to the hotline number are not monitored or recorded and the caller may remain anonymous upon request. Information obtained from the caller by an advocate or counselor is confidential, with the exception of mandatory reporting laws involving a child or elderly person. The MOU with InterAct provides for forensic exams performed at InterAct's Solace Center for victims of sexual abuse. Upon information of a sexual assault, InterAct schedules a medico-forensic exam by activating the Sexual Assault Nurse Examiner and the Sexual Assault Response Advocate on call. A medical-forensic exam includes a nurse assessment, injury assessment, photography and a sexual assault evidence collection kit. The victim is discharged with STI and pregnancy prevention prophylaxis treatment (if consenting) and after a safety assessment providing them with detailed discharge instructions and community resources. Following the forensic exam, the victim would receive a follow-up call after three days from one of InterAct's Sexual Assault Case Managers. InterAct advocates can provide accompaniment during law enforcement

interviews, but they do not provide legal counseling. All services provided are at no cost to the victim.

During the site review the locations of cameras and mirrors, room layouts, restrooms and the placement of PREA posters and information was observed. Facility notices in English and Spanish provided during the Pre-Onsite Audit Phase were found displayed in numerous locations throughout the facility with the date posted noted as 12/6/24. Resident PREA reporting information was posted in numerous locations throughout the facility and in all resident rooms. The practice of opposite gender announcements was observed and confirmed during interviews with residents and staff. During the site review nine residents were informally questioned about their knowledge of PREA and the methods of reporting available to them.

The Voyce access number was called and found to be accessible. At the time of the onsite audit visit, there were no clients who were limited English proficient. On the second day of the audit, the PREA initial risk screening was observed during the intake of one client.

When entering housing units there is a clear view of the entire area with no blind spots noted. Restrooms have toilet stalls with full doors and individual showers with curtains for privacy.

The facility has 32 cameras, 16 exterior and 16 interior cameras. A DVR is located in a panel room adjacent to the day room. Data is retained for up to 90 days. Camera monitors were reviewed with the Monitor II and all were operable and provide good coverage.

Page 3 of the policy includes definitions of prohibited behaviors. Sexual activity between clients or employees, contractors and volunteers are strictly prohibited and subject to administrative and criminal disciplinary sanctions. CoreCivic’s policy 14-2 CC is comprehensive and clearly outlines the procedures to be followed to reduce and prevent sexual abuse and sexual harassment of clients. The policy addresses each standard as guidance to staff ensuring compliance to the PREA standards. Information about the zero-tolerance policy can be found on page 4, section A of policy 14-2 CC. All employees and contractors sign a <i>PREA Zero Tolerance Policy Acknowledgment</i> form (14-2J-CC) acknowledging understanding of the CoreCivic Zero Tolerance policy.</p> <p>115.211 (b): The agency employs a PREA Coordinator, who when interviewed on 8/13/24, reported that she has sufficient time and authority to develop, implement</p>

and oversee CoreCivic's efforts to comply with the PREA standards. The agency employs an upper-level, agency-wide PREA Coordinator at the corporate level. The agency's organizational chart depicts the PREA Coordinator's position within the agency. The PREA Coordinator answers to the Vice President, Core Services. The PREA Coordinator oversees the agency's efforts to comply with the PREA standards in all CoreCivic's facilities. Page 4, section A-2 of policy 14-2 CC outlines the responsibilities of the PREA Coordinator. When interviewed, the PREA Coordinator stated she has sufficient time and authority to oversee the agency's PREA program. The PREA Coordinator stated, "We assist the facility with corrective action plans as a result of audits. If the issue is a policy problem; we can look to a policy revision if necessary. We are able to provide technical on-site assistance for training that can correct incorrect practices that may have developed due to a misunderstanding of PREA standards. In my position, I am also able to involve CoreCivic Managing Directors and VPs to elevate concerns that need to be addressed at that level. We also have contracted PREA auditors that can be sent to facilities, if necessary."

The Treatment Manager is designated as the facility's PREA Compliance Manager, and at this time is the Acting Facility Director. The responsibilities of PREA Compliance Managers are found on Page 2 of policy 14-2 CC. The PREA Coordinator stated, "At any given time, there are approximately 57 PREA Compliance Managers, including those from Community Corrections. The PREA office consists of two individuals. I am the Senior Director and handle audits and compliance issues including policy. Jillian Shane is a director and coordinates PREA investigation and training efforts. We have Quarterly Training sessions with PREA Compliance Managers via Skype and travel to the facilities for audits and training sessions. We are in contact with them daily on investigation and audit issues. If we are not at the facility in person, we generally communicate via Teams for meetings and training or e-mail and telephone for normal business correspondence." When interviewed the Treatment Manager/PREA Compliance Manager stated she has sufficient time to manage her PREA-related responsibilities.

The facility was found to exceed in the requirements of this standard. The agency's 14-2 CC policy was found to be very comprehensive and both the PREA Coordinator and the PREA Compliance Manager were very knowledgeable of their responsibilities of maintaining a zero-tolerance facility.

Clients and staff interviewed confirmed announcements are made and clients shared they feel they have privacy when they shower, toilet and change clothing when female staff are in their housing unit.</p> <p>115.215 (e): According to policy 14-2 CC, pages 15 &amp; 16, section J-10, searches or physical examinations of transgender and intersex residents for the sole purpose of determining the resident's genital status is prohibited. If the resident's genital status is unknown, it may be determined during conversations with the resident, by reviewing the medical records, or, if necessary, by a medical examination conducted in private by a medical practitioner. In interview of random staff, they knew that this was prohibited by policy. At the time of the onsite audit visit, there were no transgender or intersex clients assigned to the Corpus Christi Transitional Center.</p> <p>115.215 (f): All searches of transgender and intersex residents shall be conducted in a professional and respectful manner and in the least restrictive manner possible consistent with security needs. In addition to general training provided to all staff, staff receive training on how to conduct cross-gender pat-down searches and searches of transgender and intersex residents in accordance with the gender of the institution or housing assignment which they are assigned. Transgender and intersex residents may request an exception. The exception must be authorized by the Facility Director and clearly communicated to relevant staff through a memorandum. The <i>Search Procedures</i> curriculum was provided for review. Staff are trained on how to conduct pat searches, including searches of transgender and intersex residents, in a professional and respectful manner. Receipt of this training was verified through review of the training curriculum, review of random staff training records and confirmed in interviews with staff who reported they receive training on search procedures annually. Random staff interviewed reported cross gender pat searches are not allowed.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<p><b>Auditor Discussion</b></p> <p>115.216 (a): Based on review of policy 14-2 CC, pages 12 &amp; 13, section H-6-8, residents are provided PREA education in formats accessible to all residents, including those who are deaf or hard of hearing, blind or have low vision, cognitive deficits or have limited reading skills. The facility will ensure information is effectively communicated orally if necessary. In interview with the Vice President, Core Services (agency head designee), he stated, "CoreCivic has recently (2024) entered into a new contract with the vendor Voyce for all interpretation and translation services. Voyce allows every person at every facility to have immediate</p>

access to an interpreter multiple ways: website, video chat, phone call, etc. We have also used them to translate resident handbooks into Spanish before. If a resident has other disabilities, staff is trained to convey all information to them however appropriate (reading a document or helping someone find information, etc.) There are also multiple reporting options at each facility to ensure that all residents have a means of making a report either to CoreCivic or to an outside agency if they need help." The facility has a TTY but does not utilize the TTY to communicate with residents who are deaf or hard of hearing. The Voyce is used for sign language interpretation and the Texas Correctional Office on Offenders with Medical or Mental Impairments (TCOOMMI) may be reached at 512-371-1200 to provide assistance. The Corpus Christi Transitional Center can reach out to local resources in the community. South Texas Light House for the Blind helps adults with visual impairments and the Deaf and Hard of Hearing Center of Corpus Christi can provide sign language (ASL) interpreters and other services to clients who are deaf or have a hearing loss. At the time of the onsite audit visit, there were no clients assigned to the facility who were deaf, hard of hearing, blind, with low vision or with cognitive deficits.

In interview of eight Monitor staff, none of them were familiar with the Voyce. This information was brought to the attention of the Treatment Manager/PREA Compliance Manager and it was recommended she provide some training on how to access the Voyce when needed to convey PREA information to clients who are hearing impaired or not English proficient. On 1/28/25 the Treatment Manager/PREA Compliance Manager forwarded a 4-2A, *Training Activity Enrollment/Attendance Roster* for training provided to 20 employees on 1/16/25 on how to access the Voyce.

115.216 (b): The agency takes steps to ensure those who are limited English proficient have access to all PREA information in a format they can understand. Residents receive a *Therapeutic Community Center Handbook* and a *CoreCivic PREA Prevent, Detect, Respond* brochure, both available in English and Spanish. Residents view the *PREA: What You Need to Know* video. The *PREA: What You Need to Know* video was available in only English at this facility. Since the video is not the most updated version of the PREA video, it was recommended the facility not show the video any longer as the standard does not require it to be shown. Bilingual staff provide translation of PREA information for Spanish speaking clients and a contract with Voyce is used for the translation of any other language. At the time of the onsite audit visit, there were no clients assigned to the facility identified as limited English proficient.

115.216 (c): The agency prohibits use of resident interpreters, resident readers, or other types of resident assistants except in limited circumstances. Staff translators or Voyce services are utilized to convey information to limited English proficient residents. From information provided on the Pre-Audit Questionnaire, in the past 12 months, there have been no instances where clients were used for this purpose. Random and specialized staff interviewed knew the agency prohibits using clients to interpret for other clients.

	<p>115.217 (a): Per policy 14-2 CC, pages 4 &amp; 5, section B-1, the agency prohibits hiring or promoting anyone who may have contact with residents and prohibits enlisting the services of any contractor who may have contact with residents who have engaged in sexual abuse in a prison, jail, lockup, community confinement, juvenile facility or other institution. It also prohibits hiring or promoting anyone who has been convicted of engaging or attempting to engage in sexual activity in the community or who has been civilly or administratively adjudicated to have engaged in these activities.</p> <p>115.217 (b): CoreCivic considers any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. The agency requires that all applicants and employees who may have contact with residents have a criminal background check. NCIC/TCIC criminal background checks are conducted by the Texas Department of Criminal Justice (TDCJ) on all applicants and volunteers. Once an applicant has been selected to be hired, a contract with First Advantage provides for a check on education, driving record, previous employment and drug screening. In the past 12 months, the facility has not utilized the services of contractors.</p> <p>115.217 (c): The agency requires that before hiring new employees a criminal background check be conducted. According to information provided on the Pre-Audit Questionnaire, 40 criminal background checks were conducted by the Texas Department of Criminal Justice (TDCJ) in the past 12 months. An effort is made to contact all prior institutional employers by telephone for information on substantiated allegations of sexual abuse or sexual harassments or any resignations during a pending investigation of an allegation of sexual abuse or sexual harassment. The Corpus Christi Transitional Center makes its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any pending investigations of allegation of sexual abuse. In interview with the Human Resource/Financial Coordinator, the request is documented on the <i>Verification of Employment</i> form (3-20-2A). In review of 18 employee human resource files, seven employees reported prior institutional employment and 3-20-2B forms were completed in all cases.</p> <p>115.217 (d): Agency policy requires that criminal background checks be completed on any contractor who may have contact with residents. The Corpus Christi Transitional Center does not utilize the services of contractors.</p> <p>115.217 (e): CoreCivic requires that criminal background checks be conducted every five years on current employees and contractors who have contact with residents. Due to a Flash Reporting system in the state of Texas, criminal background checks are not required every five years. The fingerprints of employees and volunteers are submitted and kept on file with the Department of Public Safety</p>

(DPS). DPS notifies TDCJ any time there is an arrest of an employee or contractor eliminating the need for additional criminal background checks after the initial NCIC/TCIC check.

115.217 (f): All applicants, employees, contractors and volunteers are asked about previous misconduct as stated in section 115.217 (a). Agency policy requires that the 14-2 CC-H, *Self-Declaration of Sexual Abuse/Sexual Harassment* form be completed as part of the hiring process and as part of the promotional process. The CoreCivic online application form has a section that requires disclosure of misconduct and may be used in lieu of the 14-2H-CC form. In interview of the Human Resource/Financial Coordinator and in review of 18 human resource files, this process is currently in place. Files reviewed had annual 14-2H forms for employees assigned to the facility since the last PREA audit and for new hires and those considered for promotions.

115.217 (g): CoreCivic policy mandates that material omissions regarding sexual misconduct and the provision of materially giving false information are grounds for termination as required by this standard. Employees have a continuing affirmative duty to disclose any sexual misconduct.

115.217 (h): CoreCivic shall provide information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom the employee has applied to work. In interview of the Human Resource/Financial Coordinator, Thomas and Company, a third-party company, is used to request this information.

The facility was found to exceed in the requirements of this standard. In review of 18 employee human resource files all records were orderly and complete with required documentation.

	115.218 (a): Based on policy 14-2 CC, page 8, section E, when designing or acquiring any new facility and in planning any substantial expansion or modification of existing facilities, CoreCivic will consider the effect of the design, acquisition, expansion or modification of existing facilities on the ability to protect residents from sexual abuse. In interview with the Vice President, Core Services (agency head designee) he stated "The CoreCivic Real Estate Department is responsible for all new projects related to physical plant upgrades and modifications. The one exception to that is technology managing efforts to increase or ameliorate camera systems in facilities. Part of this process is the completion of 7-20-2A form, which documents PREA specific considerations of any project of this sort. 	<p>115.221 (a): Based on policy 14-2 CC, pages 27 &amp; 28, section O-4, CoreCivic and Corpus Christi Transitional Center are responsible for conducting administrative sexual abuse investigations on both resident-on-resident and staff sexual misconduct. There are three trained facility investigators responsible for conducting administrative investigations of sexual abuse and sexual harassment. All reports of sexual abuse that appear to be criminal are referred to the Corpus Christi Police Department who follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence and fulfill all requirements of this standard. Random staff interviewed knew how to preserve the evidence and the crime scene.</p> <p>The facility has attempted to enter into a Memorandum of Understanding (MOU) with the Corpus Christi Police Department and those attempts are ongoing. On 1/3/25, the Lieutenant of the Criminal Investigations Division/Family Violence and Child Criminal Crimes Unit of the Corpus Christi Police Department was called to discuss the procedure in the event there was an allegation of sexual abuse reported at the Corpus Christi Transitional Center. The facility has made ongoing attempts to secure an MOU with the Corpus Christi Police Department. To date, those attempts have</p>

been unsuccessful. Absence of an MOU, the Lieutenant stated the Corpus Christi Transitional Center is within the Police Department's jurisdiction and a patrol officer would be dispatched to the facility if notified of an incident of sexual abuse. The patrol office would take an initial report of the incident. The alleged victim would be offered a SANE exam at the Rape Crisis Center located at Doctor's Regional Medical Center. A detective would be assigned to conduct a criminal investigation.

115.221 (b): The protocol is developmentally appropriate for youth where applicable and as appropriate, shall be adapted from or otherwise based on the most recent edition of the Department of Justice's Office on Violence Against Women publication. "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents" or similarly comprehensive and authoritative protocols developed after 2011.

115.221 (c): Victims of sexual abuse have access to forensic medical examinations. Clients in need of forensic exams are transferred to the Doctor's Regional Medical Center where SANE exams are performed at no cost to the resident. On information provided on the Pre-Audit Questionnaire, in the past 12 months, there were no referrals of clients for SANE exams.

115.221 (d): CoreCivic and the Corpus Christi Transitional Center have a Memorandum of Understanding (MOU) with the Purple Door to provide confidential emotional support services to the clients of the Corpus Christi Transitional Center. On 1/9/25 the Sexual Assault Services Manager was contacted to confirm and review the services the Purple Door provides. The Purple Door has a 24/7 sexual abuse crisis line manned by 2-3 staff advocates. All calls to the crisis line are confidential and are not monitored or recorded. If a caller calls and reports sexual abuse that occurred within five days of the call, the advocate taking the call would discuss reporting options with the alleged victim and encourage him/her to report the allegation to the facility or to law enforcement. Alleged victims of sexual abuse are transported to the Doctor's Regional Medical Center for SANE exams. SANE nurses contracted through Driscoll Children's Hospital would be dispatched to the Doctor's Regional Medical Center and the alleged victim would be offered an advocate from the Purple Door to accompany him/her through the SANE exam process. Female victims are given a pregnancy test and if the test is negative, given Plan B prophylactics. All alleged victims are given STD prophylactics. The Purple Door also offers legal advocacy and referrals for legal aid, in addition to providing assistance with paperwork for Orders of Protection and Crime Victims Compensation. The Purple Door also provides Case Management services. All services provided are at no cost to the alleged victim.

The contact information for emotional support services is provided to residents via the resident handbook and is posted on the walls of the facility near all resident phone banks or on bulletin boards in common areas." When asked how the agency ensures that the rape crisis center meets the qualifications described in 115.221 (d), the PREA Coordinator responded, "We include these stipulations in the MOU that we sign with the agency providing these services. Both CoreCivic and the agency retain copies of the final and signed MOU."

	<p>115.221 (e): As requested by the victim, an advocate from the Purple Door would be called upon to accompany the victim through the forensic exam process. The <i>PREA Overview</i> curriculum was provided for review. Clients receive a TDCJ <i>Therapeutic Community Center Handbook</i> and a <i>CoreCivic PREA Prevent, Detect, Respond</i> brochure (14-2AA) on day of arrival to the facility and view the <i>PREA: What You Need to Know</i> video. Interview of two Monitor II and three Treatment Counselors confirmed what information clients receive upon arrival to the facility. Clients interviewed confirmed they received written PREA information upon arrival to the facility and confirmed viewing the PREA video. During the onsite audit visit it was discovered the facility was not showing the updated PREA video and did have a Spanish version of the one they were showing. It was recommended for the facility to discontinue showing the PREA video as it is not required by the standard.</p> <p>115.233 (b): Clients who transfer from another community confinement facility receive the same PREA education as all clients assigned to the facility. In information provided on the Pre-Audit Questionnaire, in the past 12 months there</p>

	<p>were no clients who transferred from a different community confinement center.</p> <p>115.233 (c): Clients are provided PREA information in formats accessible to all clients. Written PREA information and posted information is provided in both English and Spanish. The facility has a contract with Voyce to provide translation of PREA information in any language. Sign language interpretation is provided through Voyce or through community resources for clients who are deaf, hard of hearing blind, or with low vision.</p> <p>115.233 (d): Twenty client records were reviewed to determine compliance to the requirements of PREA education for clients. On day of arrival to the facility clients sign an <i>Initial Orientation Form</i> acknowledging receipt the <i>Therapeutic Community Center Handbook</i> acknowledging receipt and understanding of the written and verbal PREA information they received. They also sign a <i>Zero Tolerance Acknowledgement for Offenders (115.233)</i> form acknowledging receipt of the CoreCivic pamphlet (14-2 AA), the <i>Therapeutic Community Center Handbook</i> and viewing the PREA video. Since the facility will no longer be showing the PREA video to residents, a new form, <i>PREA Education Acknowledgement</i>, was developed. Clients will now sign the new form acknowledging receiving the Core Civic 14-2 AA pamphlet and the <i>Therapeutic Community Center Handbook</i>. The facility also provides clients with pages 17-19 of the <i>Therapeutic Community Center Handbook on Grievance Procedures</i>. The client signs on page 19 that they have received and understood the <i>Grievance Procedures</i>.</p> <p>115.233 (e): Ongoing information is provided continuously on posters, both in English and Spanish, prominently displayed in various locations throughout the facility.</p> <p>All clients interviewed were aware of the zero-tolerance policy and methods of reporting sexual abuse and sexual harassment available to them. Clients interviewed shared they received written and verbal PREA information and viewed the PREA video when they first came to the facility. In review of 20 resident records all files contained required documentation of PREA education, the facility was found to exceed in the requirements of this standard.</p>

The facility has four trained facility investigators: the Treatment Manager/PREA Compliance Manager, Maintenance Supervisor, a Monitor II and the Medication Monitor. When interviewed, investigators confirmed completing specialized</p>

The facility also maintains documentation of the general PREA training provided to all employees completed by the facility Investigator. When interviewed, investigators knew their responsibilities in conducting administrative investigations of sexual abuse and sexual harassment and their responsibility for referral of any allegations that appear to be criminal to the Corpus Christi Police Department.</p>

	<p>115.235 (a): According to CoreCivic policy 14-2 CC, pages 6 &amp; 7, section C-6-7, in addition to the general training provided to all employees all full and part-time Qualified Health Care Professionals and Qualified Mental Health professionals, working at CoreCivic facilities receive specialized medical/mental health training. The training includes how to detect and assess signs of sexual abuse and sexual harassment, how to preserve physical evidence, and how to respond effectively and professionally to victims of sexual abuse and sexual harassment.</p> <p>The Corpus Christi Transitional Center does not employ medical or mental health staff. Medical and mental health services are provided by referral to outside community providers.</p>

	<p>115.241 (a): Clients are screened for their risk of being sexually abused or sexually abusive towards others according to policy 14-2 CC, pages 9-11, section G. Upon admission to the Corpus Christi Transitional Center, all clients are screened for their</p>

risk of being sexually abused or sexually abusive towards others. The Monitor II's and Monitor III's screen clients upon admission to the facility. Two Monitor II's interviewed explained the intake screening process. On the second day of the onsite audit visit, the screening of one newly assigned client was observed. The client was taken into a private office and screened with the door closed. The screener verbally informed the client of the zero-tolerance policy giving the client an opportunity to ask any questions of the screener.

115.241 (b): At the Corpus Christi Transitional Center, intake screening is completed within 24 hours of arrival to the facility. In information provided on the Pre-Audit Questionnaire, in the past 12 months, 761 residents assigned to the facility were screened within 24 hours of arrival for their risk of sexual victimization and sexual abusiveness. In review of 20 client records and in interview of clients confirmed clients are being screened within 24 hours of arrival to the facility. Monitor II's interviewed stated clients are screened upon arrival as part of the intake process.

115.241 (c): Clients are screened, using CoreCivic's *Sexual Abuse Screening Tool* (14-2B-CC), an objective screening tool. The 14-2B-CC is completed either on a paper 14-2 CC form and then the information is transferred on a 14-2B-CC form in COATS, an electronic assessment tracking program, or entered directly on the 14-2B-CC form in COATS.

115.241 (d): In review of the screening tool, it was found to consider all of the criteria required in this provision of this standard. The two Monitor II's and the three Treatment Counselors interviewed confirmed the information the *Sexual Abuse Screening Tool* (14-2B-CC) screening tool contains.

115.241 (e): The initial screening considers prior acts of sexual abuse, prior convictions for violent offenses, and history of prior institutional violence or sexual abuse in assessing residents for risk of being sexually abusive, as confirmed by review of the screening form and in interview of two Monitors II's.

115.241 (f): According to policy 14-2 CC, page 11, section G-11, between 20-30 days after arrival to the facility, clients are rescreened by their Treatment Counselor using the *Sexual Abuse Screening Tool* (14-2B-CC) to reassess the resident's risk of victimization or abusiveness. According to information provided on the Pre-Audit Questionnaire, in the past 12 months 761 clients assigned to the facility whose length of stay was over 30 days were reassessed for their risk of victimization or abusiveness. The Treatment Counselors track the due dates and completion dates of 30-day reassessments in COATS on the *COATS PREA Completion Report*. In review of 30-day reassessments to determine compliance with screening procedures, all reassessments were completed prior to the 30-day due date.

115.241 (g): In interview of the Treatment Counselors, a client's risk level would be reassessed when warranted due to a referral, request, incident of sexual abuse, or receipt of additional information that bears on the resident's risk of sexual victimization or abusiveness.

	<p>115.241 (h): Clients are not disciplined for refusing to answer or for not disclosing complete information in response to questions asked on the screening form.</p> <p>115.241 (i): The 14-2B-CC forms are stored electronically in COATS. To maintain confidentiality of screening information, access to this information is allowed to employees who have access to COATS. In interview of the PREA Coordinator she stated, "It is in policy that access to the 14-2B and/or partner agency risk assessments are secured in the inmate's file in record offices where access is controlled to only those who need access such as Case Managers and treatment personnel. Those assessments on computers are protected by passwords and are not accessible to all staff." Paper copies of the 14-2B-CC forms are printed from COATS and filed in locked filing cabinets in the respective Treatment Counselors' office. Access to this information is allowed to Treatment Counselors and administration staff only.</p>

	<p>115.242 (a): The agency uses the information from the risk screening form to make housing, bed, work, education and program assignments with the goal of separating clients at high risk of being sexually victimized from clients with those at high risk of being sexually abusive. Individualized determinations are made about how to ensure the safety of each client. Policy 14-2 CC, page 12, section I-1, addresses the use of the information obtained during the screening process. In interview with the PREA Coordinator she stated, "Risk assessment information is used to assign housing, jobs and programs. CoreCivic does not house victims with predators, and we try to house especially vulnerable populations in safer areas: ones where there is better camera coverage or that are closer to monitor stations, etc. If there is a safety concern raised in the risk assessment process, it is addressed and considered when assigning housing, jobs and programs."</p> <p>115.242 (b): Pages 12 &amp; 13, section I of policy 14-2 CC, addresses how individualized determinations on a case-by-case basis are made about how to ensure the safety of each client. In interview with Treatment Counselors and the Treatment Manager/PREA Compliance Manager they explained how the facility utilizes information from the screening to keep clients safe from sexual abuse. Clients who score at risk for victimization or abusiveness are not housed together. In interview of the Treatment Manager/PREA Compliance Manager and those responsible for conducting risk screenings stated those that score to be victims, or potential victims are housed in A Dorm and those who score to be a predator or potential predator are housed in C or D Dorms. Victims and predators are tracked</p>

on a *PREA Alert Roster* generated by screening information entered into COATS.

115.242 (c): Guidelines on housing and program assignments for the management of transgender and intersex clients are outlined in policy 14-2 CC, page 12, section I-7. In deciding whether to assign a transgender or intersex clients to a facility for male or female residents, CoreCivic considers on a case-by-case basis whether the placement would ensure the client's health and safety and whether the placement would present management or security problems. In interview with the PREA Coordinator she stated, "In addition to initial and follow-up risk assessments, CoreCivic has a 14-9 policy that includes a *Transgender and Intersex Assessment* form (14-9A form). This form is used to document preferences regarding pronouns, searches, showering separately, medical needs and other issues inherent to those who identify as transgender or intersex. All transgender residents are reassessed for their risk and needs twice a year. These assessments and conversations are used to inform housing, job and program placements to protect resident from victimization."

115.242 (d): Transgender and intersex clients are reassessed at least twice a year to review placement and programming assignments and any threats to safety experienced by the client. In interview with the PREA Coordinator she stated, "A conversation is had with any resident who identifies as transgender or intersex upon intake (or soon thereafter) where they are asked who they want to search them, whether they feel safe housed at the facility, and an assessment about their individual needs and wants are considered." Treatment Counselors interviewed were knowledgeable of this requirement. At the time of the onsite audit visit, there were no clients who self-disclosed being transgender or intersex. In interview of Treatment Counselors, they confirmed this requirement.

115.242 (e): According to agency policy, transgender and intersex residents are given the opportunity to shower separately from other residents. In interview with the PREA Coordinator she stated that transgender and intersex residents are given the opportunity to shower separately from other clients. On information in a memo regarding the transgender shower protocol, the Treatment Manager/PREA Compliance Manager stated clients who identify as transgender can shower alone at their request. The bathroom should be checked to ensure no other clients are in the shower. In interview of Treatment Counselors, they confirmed transgender and intersex clients are offered the opportunity to shower alone.

115.242 (f): The agency does not place lesbian, gay, bisexual, transgender, or intersex residents in dedicated facilities, units, or wings solely on the basis of their identification. In interview with the PREA Coordinator she stated, "It is against CoreCivic policy and practice to place all LGBTQ residents in a designated housing unit based on gender identity, sex, or sexual orientation. When we conduct training, staff is instructed that this is an unacceptable approach to making housing and placement decisions." The PREA Coordinator stated the agency and facility is not subject to a consent decree, legal settlement, or legal judgement requiring that it establish a dedicated facility, unit or wing for lesbian, gay bisexual transgender or intersex clients.

	<p data-bbox="280 188 983 224"><b>Auditor Overall Determination:</b> Meets Standard</p> <hr/> <p data-bbox="280 264 564 300"><b>Auditor Discussion</b></p> <p data-bbox="280 340 1481 875">115.251 (a): Policy 14-2 CC, pages 17 &amp; 18, section K-1, outlines the procedures for client reporting of allegations of sexual abuse and sexual harassment, retaliation by other clients or staff or staff neglect or violation of responsibilities that may have contributed to such incidents. Clients are informed of the zero-tolerance policy and methods of reporting in the CoreCivic <i>PREA Prevent, Detect, Respond</i> brochure and on pages 6 &amp; 7 of the <i>Therapeutic Community Center Handbook</i> and on TDCJ and CoreCivic information posted throughout the facility in both English and Spanish. Clients are informed they can report allegations to the Facility Director, the PREA Compliance Manager or other supervisory staff by forwarding a letter, sealed and marked “confidential” and can verbally report to any staff member or to a volunteer. They are also told family and friends can report an allegation on their behalf as a third party. Third party information is available on <i>Speak Up</i> posters. Clients and staff interviewed were aware of reporting options available to them.</p> <p data-bbox="280 916 1481 1534">115.251 (b): Residents are also informed that they have options to report abuse or harassment to a public or private entity that is not part of the agency. Residents are provided with the telephone numbers, mailing addresses and website addresses for the TDCJ PREA Ombudsman's Office, TDCJ Ombudsman Office, or the Corpus Christi Police Department. In interview the PREA Coordinator she stated, "Each facility has a different external reporting source identified, depending on the partner and jurisdiction. At some facilities, the address to the local sheriff or police department is provided. The residents have access to resources at the partner agency in addition to the CoreCivic resident concern line and Ethics Line, where they can remain anonymous making a report. All internal and external reporting resources are posted near the phone bank at the facility and are included in the resident handbook." She further stated, "Whenever we establish a partnership with an external reporting source, we ensure that the agency that we partner with understands these requirements. In the case of a police partner, they either call the facility or respond directly when a complaint is received."</p> <p data-bbox="280 1574 1481 2067">On the first day of the audit the external reporting options numbers and the numbers to the Purple Door were called on resident pay phones. Some of the resident phones did not have dial tones. The number to the TDCJ PREA Ombudsman Office (1-936-437-5570) was found to be a toll-free call and accessible. Other numbers dialed and not found accessible were the TDCJ Ombudsman Office (1-936-437-4927), Corpus Christi Police Department (362-886-2600) and TDCJ Office of Inspector General (OIG) (1-936-437-5116). These numbers were not toll-free and could not be dialed. The Manager, QA Compliance Community Corrections contacted the facility's telephone vendor to request external reporting numbers be programmed to be toll-free. On the second day of the audit the Treatment Manager/ PREA Compliance Manager reported she received an e-mail from the telephone vendor (Crown Phone Company) stating the numbers had been programmed. The</p>

Treatment Manager/PREA Compliance Manager was asked to try the numbers to confirm this information. She found that all phones were in working order, with the exception of two phones (3 & 7) in Dorms E and F were not working. On 1/31/25 the telephone vendor technician came again to service the two phones. On 2/3/25, the Treatment Manager/PREA Compliance Manager, the Maintenance Supervisor and the Monitor 3 did a final test of all 12 resident phones. All phones were operational and numbers for the TDCJ PREA Ombudsman Office and the Corpus Christi Police Department were found to be toll-free. On 2/4/25 the Treatment Manager/PREA Compliance Manager confirmed this information in an e-mail.

In discussion with the Treatment Manager/PREA Compliance Manager and the TDCJ Contract Monitors who were onsite during the audit visit, the TDCJ poster displayed in all housing units had a number that was no longer in existence. It was decided that poster would be removed from all locations and a new posting in English and Spanish from the TDCJ PREA Ombudsman Office would be posted in its place. It was also determined that the CoreCivic posters be revised to instruct clients to report to staff immediately or to call 1-936-437-5570 to reach the TDCJ PREA Ombudsman's office or 1-361-886-2600 to reach the Corpus Christi Police Department. To date the posters have not been delivered. When delivered and posted, the Treatment Manager/ PREA Compliance Manager will forward photos of posters.

115.251 (c): Employees must take all allegations of sexual abuse and harassment seriously whether they be made verbally, in writing, anonymously and from third parties and are required to promptly document all verbal reports as stated on page 18, section K-2-b of policy 14-2 CC. Staff interviewed knew the reporting options for residents and knew verbal reports must be documented. Staff who fail to report allegations may be subject to disciplinary action.

115.251 (d): According to policy 14-2 CC, page 19, section K-2-f, CoreCivic employees, contractors, volunteers and third parties may privately report sexual abuse and sexual harassment of residents in writing or may contact the CoreCivic's Ethics and Compliance Hotline at 1-800-461-9330 or report on CoreCivic's website at [www.corecivic.com/ethicsline](http://www.corecivic.com/ethicsline). Reporting methods can be found on the CoreCivic website and in the CoreCivic Code of Ethics, pages 16 & 17. Staff are informed of the Ethics Line on *Speak Up* posters. Employees can also report in writing to the Facility Director in a sealed envelope marked "Confidential".

Clients interviewed were aware of the methods of reporting available to them. Staff interviewed were aware of privately reporting sexual abuse of clients by calling the agency's Ethics and Compliance hotline, reporting on the Ethics Line website and in writing to the Facility Director confidentially.

115.252 (a): According to CoreCivic policy 14-2 CC, page 18, section K-1-d, CoreCivic facilities do not maintain administrative procedures to address resident grievances regarding sexual abuse, unless specifically mandated by contract. The contracting agency, the TDCJ mandates the Corpus Christi Transitional Center follow TDCJ's Operational Plan RRC 2.8, *Grievances*, in resolution of PREA-related concerns. Clients are informed of the grievance procedures in the TDCJ *Therapeutic Community Center Handbook*. Clients also receive pages 17-19 of the Handbook related to Grievance procedures at intake and sign on page 19 acknowledging receipt of the information. Clients interviewed knew they could file a grievance alleging sexual abuse or sexual harassment.

115.252 (b): According to RRC 2.8, page 2, section VII A, if a grievance is deemed by the Grievance Coordinator to be an emergency grievance or has PREA-related concerns, the grievance shall be given immediate attention. Attachment C to TDCJ Operational Plan RRC 2.8, *Grievance Emergency Checklist*, is used to determine if a grievance is an emergency grievance or if the grievance alleges sexual abuse.

There is no time limit on when a client may submit a grievance regarding an allegation of sexual abuse and the grievance may be reported by a third party.

PREA related grievances do not require informal resolution. The Treatment Manager/PREA Compliance Manager will be informed immediately if a client submits a grievance alleging sexual abuse or sexual harassment. In interview of the Treatment Manager/PREA Compliance Manager and on information reported on the Pre-Audit Questionnaire, in the past 12 months there were no PREA-related grievances filed. The Grievance Log for the past 12 months was requested during the onsite audit visit. In review of the Grievance Log, it was confirmed there were no PREA-related grievances filed in the past 12 months.

115.252 (c): Clients who allege sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint.

115.252 (d): The grievance plan and procedures require a decision on the merits of any grievance or portion of a grievance alleging sexual abuse be made within 90 days of the filing of the grievance.

115.252 (e): Third parties, including other residents, can file a grievance on behalf of a resident. If a third-party file a grievance on behalf of a resident, the alleged victim must agree to have the request filed on his or her behalf. If the resident declines to have the request processed on his or her behalf, the agency shall document the resident's decision.

115.252 (f): If the facility receives a grievance that is determined to be an emergency grievance alleging a client is subject to a substantial risk of imminent sexual abuse it is required the highest-ranking supervisor be notified and immediate written notification be made to appropriate staff. An investigation will immediately be initiated.

115.252 (g): If a client is found to have intentionally filed a false grievance or an allegation against another individual shall be subject to disciplinary action.

Client are given the telephone number and the mailing address to the Purple Door where clients can request victim advocacy and emotional support services. Clients are informed of services the Purple Door provides on posted information and in the <i>Therapeutic Community Center Handbook</i>, page 6. In interview with clients, they knew where to find information about services for victims of sexual abuse.</p> <p data-bbox="280 707 1477 945">115.253 (b): Residents are informed prior to giving them access to outside victim advocates to the extent to which such communication will be monitored and to the extent which reports of abuse will be forwarded to authorities in accordance with mandatory reporting laws. Clients are informed that calls to the Purple Door are not recorded or monitored. When interviewed, random residents knew they could remain anonymous upon request.</p> <p data-bbox="280 985 1477 1393">115.253 (c): CoreCivic and the Corpus Christi Transitional Center have a Memorandum of Understanding (MOU) with the Purple Door to provide confidential emotional support services to the residents of the Corpus Christi Transitional Center. On 1/9/25 the Sexual Assault Services Manager was contacted to confirm and review the services the Purple Door provides. The Purple Door has a 24/7 sexual abuse crisis line manned by 2-3 staff advocates. All calls to the crisis line are confidential and are not monitored or recorded. If a caller calls and reports sexual abuse that occurred within five days of the call, the advocate taking the call would discuss reporting options with the alleged victim and encourage him/her to report the allegation to the facility or to law enforcement.</p> <p data-bbox="280 1433 1477 1715">Alleged victims of sexual abuse are transported to the Doctor’s Regional Medical Center for SANE exams. Female victims are given a pregnancy test and if the test is negative, given Plan B prophylactics. Per CoreCivic policy 14-2 CC, page 19, section K-2-f, information on third party reporting is made available on CoreCivic's website (<a href="http://www.corecivic.com/ethicsline">www.corecivic.com/ethicsline</a>) with instructions for outside parties to contact the Facility Director or the PREA Coordinator and the telephone number to reach the Ethics Line (1-800-461-9330) is provided.</p> <p>Residents, staff and visitors are made aware of third-party reporting on <i>Speak Up</i> and <i>PREA Reporting Options</i> posters found in various locations throughout the facility. Posted information includes the mailing address to CoreCivic's PREA Coordinator and to the TDCJ PREA Ombudsman. They are also given the number to the CoreCivic 24-hour Ethics Line and website access. Staff are to document all verbal reports promptly. Staff who fail to report allegations may be subject to disciplinary action. Random staff interviewed knew their reporting responsibilities. The <i>PREA Overview</i> training curriculum addresses staff reporting responsibilities during pre-service and in-service training. All staff</p>

	<p>carry with them a <i>Staff Keep on Person First Responder Duties Card</i> to remind them of their responsibilities if they receive an allegation of sexual abuse.</p> <p>115.261 (b): Apart from reporting to designated supervisors, staff shall not reveal any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation and other security and management decisions. All staff carry with them a *Staff Keep on Person First Responder Duties Card* reminding them of the actions to take in the event they are a first responder to an allegation of sexual abuse. The *Sexual Abuse Incident Check Sheet (14-2C-CC)* is used to ensure all required steps and notifications are made.

On information provided on the Pre-Audit Questionnaire and in interview with the Treatment Manager/PREA Compliance Manager, in the past 12 months there were no allegations of sexual abuse or sexual harassment reported. In interview of facility investigators, they stated they would start an investigation immediately after a report of an allegation.</p>

115.271 (b): Documentation provide showed facility Investigators completed *Investigating Sexual Abuse in a Confinement Setting*, a web-based training. The training curriculum and certificates of completion of this training were provided for review. When interviewed, facility investigators confirmed completing this training and described some of the topics the training covered.

115.271 (c): The investigators gathers and preserves direct and circumstantial evidence, including physical and DNA evidence and available electronic monitoring data. In interview of Investigators, they reported they interview the alleged victims, suspected perpetrators and witnesses and named some of the evidence they would collect in their investigations.

115.271 (d): Allegations involving staff or clients that appear to be criminal are referred to the Corpus Christi Police Department. If the evidence appears to support criminal prosecution, compelled interviews will be conducted after consulting with prosecutors.

115.271 (e): The credibility of an alleged victim, suspect or witness is assessed on an individual basis and shall not be determined by the person's status as a resident or a staff. The agency does not require a resident who alleges sexual abuse to submit to a polygraph test. This was confirmed in interview with investigators.

115.271 (f): The administrative investigation shall include an effort to determine whether staff actions or failures to act contributed to the abuse. The administrative investigation is documented on the 5-1G-CC, *Incident Investigation Report*. The report includes investigative facts, physical evidence and testimonial evidence, reasoning behind credibility assessments, investigative findings and whether actions and/or failures of staff to act contributed to the incident, including explanation as to what determined the conclusion.

115.271 (g): A criminal investigation shall be documented in a written report that contains a thorough description of physical, testimonial and documentary evidence. Information on criminal investigations is found on pages 25 & 26, section O of policy 14-2 CC.

115.271 (h): Substantiated allegations shall be referred for prosecution. On information provided on the Pre-Audit Questionnaire, in the past 12 months there were no allegations of sexual abuse

On 1/3/25, the Lieutenant of the Criminal Investigations Division/Family Violence and Child Criminal Crimes Unit of the Corpus Christi Police Department was called to discuss the procedure in the event there was an allegation of sexual abuse reported at the Corpus Christi Transitional Center. The facility has made ongoing attempts to secure an MOU with the Corpus Christi Police Department. To date, those attempts have been unsuccessful.
